New Hires - Faculty

- A. Carly Peters Associate Degree Nursing Instructor 75%: Carly Peters was the Selection Committee's top choice for Associate Degree Nursing Instructor 75%. Ms. Peters holds a master's degree in the RN-MSN, Nurse Educator program from Capella University, an Associate degree in Practical Nursing, and a Nursing Assistant Technical Diploma from Northeast Wisconsin Technical College. Since August 2015, Ms. Peters has been employed as an Academic Coach/Registered Nurse for Northeast Wisconsin Technical College. Prior to that, she was a Registered Nurse for the Emergency Department at Bellin Memorial Hospital and a Registered Nurse. Placement for this position would be at the level Faculty C, \$56,170.00
- B. Isaac Vroman Anatomy & Physiology ECPN/K12 Focus Instructor: Isaac Vroman was the Selection Committee's top choice for Anatomy & Physiology ECPN/K12 Focus Instructor Mr. Vroman holds a master's degree in the Anatomy and Advanced Forensic Anthropology program from University of Dundee, and a Bachelor of Science degree in Archaeology from University of Wisconsin, La Crosse. Since 2017, Mr. Vroman has been employed as an Instructor at South Dakota State University. Prior to that, he was an instructor for Eagle Gate College. Placement for this position would be at the level Faculty C, \$70,000.00

- C. Jacob Burt Automotive Technician Instructor: Jacob Burt was the Selection Committee's top choice for Automotive Technician. Mr. Burt holds a Technical Diploma in Automotive Technology from the Universal Technical Institute, Glendale Heights, Illinois. Since 2016, Mr. Burt has been employed as an Automotive Technician at Dorsch Ford Green Bay. Prior to that, he was an Automotive Technician for Bergstrom Ford Oshkosh and Kocurek Ford Wausau. Placement for this position would be at the level Faculty A, \$63,000.00
- D. Karl Huebner Anatomy & Physiology Microbiology Instructor Marinette & District-Wide: Karl Huebner was the Selection Committee's top choice for Anatomy & Physiology Microbiology Instructor Marinette & District-Wide. Mr. Huebner holds a Doctorate in Chiropractic Medicine from National University of Health Services and a Bachelor of Science degree in Human Biology from University of Wisconsin, Green Bay. He is a licensed Chiropractor in the state of Wisconsin and a Certified Medical Examiner with the National Registry of Certified Medical Examiners. Since 2017, Mr. Vroman has been employed as a Practice Manager for Integrative Pain Management. Since 2014, he has been an independent contractor of Chiropractic Services and an Inventor/Entrepreneur for Physio F(x). Prior to that, he was a Pharmacy Technician for Streu's Pharmacy. Placement for this position would be at the level Faculty C, \$70,000.00
- E. Brandon Braden Fire Science Instructor: Brandon Braden was the Selection Committee's top choice for Fire Science Instructor. Mr. Braden holds a Master of Science in Biology degree from University of Southern Maine, a Bachelor of Science degree in Natural Resources Resource Management from Northland College, and an Associate of Science degree from Kent State University. He has multiple certifications in the areas of Wildland Fire and Structural Fire. Since 2018, Mr. Braden has been employed as an Alderperson for the city of Clintonville and a Part-Time Instructor for Public Safety at Northeast Wisconsin Technical College. Since 2015, he has held multiple positions within the Clintonville Fire Department, including Firefighter, Engineer and Lieutenant. Prior to that, he was a Forestry and Wildlife Technician for the Wisconsin Department of Natural Resources. Placement for this position would be at the level Faculty A, \$68,000.00
- F. John Gonnering Electrical Apprentice Instructor: John Gonnering was one of the Selection Committee's top choices for Electrical Apprentice Instructor. Mr. Gonnering holds an Associate Degree of Applied Science in Technical Studies-Electrical Construction and completed the ABC-Construction Apprenticeship from Fox Valley Technical College. He is a certified Wisconsin Master Electrician. Since 2014, Mr. Gonnering has been employed as an Industrial Project Manager/Account Manager for Suburban Electric. Prior to that, he was a Project Manager for Faith Technologies and held several positions with Suburban Electric, including Service Foreman and Service Technician. Placement for this position would be at the level Faculty A, \$73,000.00
- G. Christopher Wildenberg Electrical Apprentice Instructor: Christopher Wildenberg was one of the Selection Committee's top choices for Electrical Apprentice Instructor. Mr. Wildenberg holds an Associate Degree of Applied Science in Journeyman's Technical Studies and a Journeyman's Electrician Certificate from Fox Valley Technical College. He is a certified Wisconsin Master Electrician. Since 2005, Mr. Wildenberg has been employed as an Electrical Technician for Faith Technologies. Prior to that, he held several additional positions with Faith Technologies, including Senior Technical Training Consultant, Technical Training Consultant, and Robot total Station Coordinator. Placement for this position would be at the level Faculty A, \$73,000.00
- H. Jeremy Salentine Heating, Ventilation, Air Conditioning and Refrigeration Instructor: Jeremy Salentine was one of the Selection Committee's top choices for Heating, Ventilation, Air Conditioning and Refrigeration Instructor. Mr. Salentine holds an Associate Degree of Applied Science in HVAC/R Technology from Northeast Wisconsin Technical College. He is an NWTC HVAC/R Advisory Council Member and a Carrier Commercial Quality DAC Member. Since 1997, Mr. Salentine has been employed as a Distributor Service Manager / Technical Service Advisor for Temperature Systems Inc. Prior to that, was a Steel Fabricator for Tri-County Welding & Repair. Placement for this position would be at the level Faculty A, \$70,000.00

- I. Cassandra Bean Associate Degree Nursing Instructor LTE: Cassandra Bean was the Selection Committee's top choice for Associate Degree Nursing Instructor LTE. Ms. Bean holds a Master of Science in Nursing degree and a bachelor's degree of Nursing from Western Governor's University, and an Associate degree of Nursing from Northeast Wisconsin Technical College. Since August 2017, Ms. Bean has been employed as a Critical Care/Registered Nurse for the Emergency Department at St. Vincent Hospital. Since 2020, she has been a part-time Clinical Instructor for Northeast Wisconsin Technical College. Prior to that, she has held several other positions for the Hospital Sisters Health System including Emergency Department Registrar, Diagnostic Scheduler: Vascular and General Surgery, and Medical Assistant. She is licensed as a Registered Nurse. Placement for this position would be at the level Faculty C, \$72,075.00
- J. Ryan Long Pathways to Academic Success (PASS) Instructor: Ryan Long was the Selection Committee's top choice for Pathways to Academic Success (PASS) Instructor. Mr. Long holds a Master of Arts in Education from Marian College, Fond Du Lac, and a Bachelor of Arts Degree in Elementary Education from University of Wisconsin-Green Bay. He also holds a TESOL Certificate from the International Open Academy. Since May 2000, Mr. Long has been employed as an Instructor for Green Bay Public School District. Since January 2014, Mr. Long has been a Part-time ELL Instructor for Northeast Wisconsin Technical College. Placement for this position would be at the level Faculty A, \$72,000.00

It was recommended that Board approval be given for the appointments listed above.

Faculty - Resignations

With regret, the College recommended Board acceptance of the following resignation notices:

- A. Sharon Corpus Diagnostic Medical Sonography Instructor, who has been with the College since August 6, 2018 has announced her resignation effective December 21, 2021.
- B. Julia Witt AODA Coordinator Instructor, who has been with the College since August 5, 2018 has announced her resignation effective December 31, 2021.

Biomedical X-Ray Service Technician Advanced Technical Certificate

The Biomedical X-Ray Service Technician advanced technical certificate would build upon skills gained in the Biomedical Electronics Technology AAS. To move into biomed specializations which, provide greater economic rewards, additional training is needed. Opportunities in the installation, maintenance and repair of imaging equipment are growing. This is a unique program offered in the WTCS system and is a value opportunity compared to the limited private options available. Many biomed technicians would be able to advance into imaging specializations with the training we are recommending in the Biomedical X-Ray Service Technician Advanced Technical Certificate. This certificate will cover the competencies required to service X-Ray equipment and provide foundational training on digital radiography services. These competencies include safety image quality and measuring the X-Ray tube performance. By engaging with imaging services industry experts, we will be able to develop a certificate that will allow biomeds the opportunity to gain the skills and knowledge to move into imaging specializations. This program would also provide the skills necessary for other electro-mechanical technicians who may need to maintain X-Ray equipment in other environments such as airports, dentist offices, and welding inspection services.

The certificate will be comprised of 10 credits from four courses. It is anticipated that there will be 15-20 job openings in Northeast Wisconsin in the next three years. As these technologies continue to grow, the need for more biomedical X-Ray and Imaging Service technicians. The estimated wage for X-Ray Service Technicians is \$40/hour.

In a presentation at the Medical Technology Expo in Milwaukee WI in July 2021, Dr. Kenneth Hable (MD, BSRT, Director of Training & Apprenticeship Siemens Lead Engineer/Instructor) shared a presentation on the challenges of hiring qualified medical imaging service resources, "Reducing the BMET to Imaging Service Gap." Dr. Hable shared

that there is not only a current need for Medical Imaging Specialists, but the average age of the Medical Imaging Specialists is approximately 55 years old. The upcoming labor shortage could cause significant issues for healthcare providers who count on their imaging equipment running at peak efficiency.

A WTCS General Purpose Revenue (GPR) grant will be submitted for anticipated curricular and instructional expenses for the certificate. The certificate is expected to begin in Fall 2022.

It was recommended that the Board approve the Biomedical X-Ray Service Technician advanced technical certificate and authorize its submission to the WTCS State Board for approval.

Corporate Training & Economic Development (Contracts for Service)

Under the provisions of State Statutes 38.14 (3) and State Administrative Code WTCS 8, the District Board may enter into contracts to provide instructional or non-instructional services to public institutions, local governmental bodies, private institutions, industries, and businesses. District Board policy E240 delegates the authority to initiate a contract to the President, with the proviso that the contract is subject to retroactive approval by the Board. A report of fiscal year 2022 contracts pending Board approval was attached as Board Exhibit 2.

This report includes not only the in-district contracts but also the out-of-district and the out-of-state contracts. State Board Contract for Service Policy requires that the District Board receive a report at least quarterly on contracts entered into for which less than full cost is being charged. We have elected to provide the Board with this report on a monthly basis. This report uses a state formula in which the state annually calculates a percentage for indirect expenses (33.66% for on-campus and 27.75% for off-campus) such as administration, facilities, utilities, information systems, registration, counselors, insurance, etc., associated with a contract to determine full costs. The hourly rate of \$167.00 per hour along with the ability to project price was recommended by the department and approved by the Board. The intent is to recover the direct and indirect costs of delivering the services. Copies of the contracts were available for review by any interested person.

It was recommended that the Board approve the contracts for services identified in Board Exhibit 2.

Reports

Board Member Professional Development Updates

Board members were provided an opportunity to report out on any professional development activities and/or conferences they have attended since the last Board meeting.

- Trustees Hedtke, Worrick, and Sadowski attended the Boards Association meeting held at Wisconsin Rapids/Stevens Point. Ms. Hedtke was again recognized for receiving the Board Member of the Year Award. The in-service presentation was great, and a lot of information was shared on Board involvement with the Colleges they serve. Next meeting will be the legal issues session which is very well attended and is a three day event.
- The conversation also took place as to how to get the Board of Trustees more involved in their Association, whether it is to serve on a committee, the Board, or just attend the quarterly meetings. The Board Assistant will check on available materials from Boards Association.

Policy Discussion: Leadership, Identity, and Diversity

Mohammed Bey, Chief Officer for Diversity, Equity, and Inclusion began the DEI Board training with a discussion on Leadership, Identity, and Diversity.

President's Report

Enrollment Activity -

• Enrollments have dropped within the last few days to -.6 to -3%. It is thought that some of the students that are dropping are from the health area (nursing and nursing assistant) due to the increase in COVID cases and the Delta Variant. General Studies is another area that is down in enrollments since moving back to face to face with masking. During COVID most of those courses were taught online, but the College will not be going back to virtual for those classes.

Legislative and Regulatory Issues (state & federal) –

COVID-19 Update -

- The College has put back in place the masking requirement for anyone on campus whether vaccinated or not for the fall semester. We are not reinstating the physical distance requirement.
- Because many of the clinical sites that our students are being placed are requiring that they be vaccinated before they are allowed into the sites, some of them are dropping their programs. EMT is another area that utilizes clinical sites, and at one point many of those students were going to drop the training due to the vaccination requirement, but the extension on the use of simulation for contact hours for EMT students has been offered.
- Staff is now required to work 60% of the week on site with 2 days that they are allowed to work remote. However, their ability to work from home at all is dependent on the needs and the decision of their direct supervisor.
