**WHAT DOES VERIFICATION MEAN?**

Verification is the process used to check the accuracy of information submitted by students on their financial aid application. The Federal Processor chooses student applications for verification at random through computer edits. Thirty percent of all applications are selected for verification. In addition, NWTC Enrollment Services selects students for verification when inconsistent information is found.

The U.S. Department of Education requires that colleges check the accuracy of the information that you provided on the 2007-08 Free Application for Federal Student Aid (FAFSA) or the Renewal Application. We must verify this information before you are awarded financial aid. Please complete this form, attach the appropriate documentation, and return it to Enrollment Services as soon as possible.
