What Does Verification Mean?

Verification is the process used to check the accuracy of information submitted by students on their financial aid application. The Federal Processor chooses student applications for verification at random through computer edit. Thirty percent of all applications are selected for verification. In addition, the NWTC Financial Aid Office selects students for verification when inconsistent information is found.
